Invalid Expiration Date	Up to 100% of product cost + \$2/unit	High	Expiration date in ASN is in the past or less than 30 days from receive date	Ensure products have more than 90 days until expiration when shipped	Products with insufficient shelf life may expire before being sold		
Invalid/Missing ARN	1-5% of product cost	Medium	Amazon reference number in ASN is inaccurate or missing for TL/LTL shipments	Include correct ARN from routing confirmation email or EDI 754 response	Without proper reference numbers, shipments cannot be tracked effectively		
Missing Expiration Date	1-6% of product cost (higher for consumables)	Medium	Expiration date missing in ASN for products that expire	Include accurate expiration dates for all applicable products	Without expiration information, Amazon cannot properly manage inventory lifecycle		
On-Time Non- Compliance	2-6% of product cost (based on compliance rate)	Medium	ASN not submitted before shipment arrives at fulfillment center	Submit ASN within 30 minutes of carrier departure or at least six hours prior to arrival	Missing ASNs prevent Amazon from planning for arrival, allocating staff, and processing shipments efficiently		
PRO/BOL Mismatch	Varies based on compliance rate	Medium	PRO/BOL in ASN doesn't match carrier's appointment information	Ensure PRO/BOL in ASN matches carrier documentation	Mismatches cause tracking and receiving issues		
Unit Count Mismatch	Varies based on compliance rate	Medium	Units, quantity, and product identifiers in ASN don't match purchase order	Ensure ASN accurately reflects exact quantities being shipped	Mismatches cause receiving discrepancies and inventory problems

Bagging Non- Compliance	\$0.85 per unit	Low	Products requiring protection not properly bagged	Put units in transparent bags with suffocation warnings and seal the bags	Unbagged products risk damage, dust accumulation, or leaks	
Boxing Non- Compliance	\$1.61 per unit	Low	Product packaging doesn't sufficiently protect the product	Use boxes that provide adequate protection for products	Improper packaging makes extraction difficult and increases risk of product loss	
Bubble Wrap Non-Compliance	\$1.26 per unit	Low	Fragile, collectible items or products with loose pieces not properly bubble- wrapped	Apply proper bubble wrap to all fragile items or products with loose pieces	Improper packaging increases risk of damage during handling and shipping	
Cap Seal Non- Compliance	\$0.82 per unit	Low	Liquid products missing cap seals	Apply proper cap seals to all liquid products	Missing cap seals increase risk of leakage and damage	
Opaque Covering Non-Compliance	\$0.95 per unit	Low	Products with adult content not covered with non-transparent bags	Use opaque bags for products with nudity, provocative positions, or vulgar language	Products with adult content must be properly covered before delivery to customers	
Set Creation Non- Compliance	\$0.97 per unit	Low	Products with multiple units not packaged as a set	Package multiple-unit products together as sets before shipping	Products arriving as individual units require manual set creation	
Suffocation Warning Non- Compliance	\$0.63 per unit	Low	Missing suffocation warning on bagged products	Ensure all bags have proper suffocation warnings printed or labeled	Compliance with federal, state, and local packaging regulations is required

Overage PO Units	10-100% of product cost (tiered)	High	Sending more products than confirmed in a purchase order	Ship only the quantities you've confirmed in your purchase order	Excess inventory takes up valuable storage space and may lead to overstock of a product, resulting in longer sales cycles
Paper Invoices	Varies	Low	Submitting invoices using methods other than approved electronic invoicing options	Use only electronic invoicing through EDI or the Create Invoice feature in Vendor Central	Paper invoices increase processing time and costs, delaying payment processing
PO On-Time Accuracy	3-10% of product cost	Medium	Confirmed products not arriving within the purchase order window	Ship purchase orders within the agreed windows for delivery (prepaid) or for shipping (collect)	When confirmed PO line items arrive at unexpected times, are canceled, don't ship at all, or are revised down, Amazon risks providing inaccurate inventory promises to customers
Rejected PO Rate	3% of COGS for units over 20% threshold	Medium	Rejecting more than 20% of the quantity ordered in a given PO	Maintain a high confirmation rate by accepting or backordering at least 80% of each product ordered	Low purchase order confirmation rates affect Amazon's ability to fill customer orders, maintain proper inventory levels, and maintain an efficient supply chain
Unconfirmed PO Units	10% of product cost	Medium	Shipping products that were never confirmed in a purchase order	Confirm purchase orders within one day of submission through Vendor Central or EDI 855	If you fail to confirm the number of products that you will send, Amazon may fulfill their requirements through other sources

Expired Product	\$2 per unit + 100% of product cost	High	Product has expired or will expire within 90 days of receipt	Ship products with expiration dates more than 90 days from delivery date	Products with insufficient shelf life cannot be sold to customers
